The Fire District Board cannot discuss or take legal action (and in lieu of Board, Administrator may not discuss or take legal action) on any issue raised during the Call to the Public, unless that issue is listed on the agenda and the time of that discussion/action item.

No Member of the Board or the public shall be allowed to speak for a period longer than three minutes without the leave of the presiding officer.
