1. We have been on no additional Wildland assignments since the last meeting. We currently have billed out to Arizona State Forestry Division \$ 75,233.39

- 1. E305 has steering box leak. Western States will be here Friday morning.
- 2. E 306 is having transmission problems, we will be investigating.

Communication:

- 1. We did receive a \$100,000 donation from the private donor. We will be purchasing a fire prevention trailer, work out equipment, protective gear, Thermal imaging camera, laptops, and trailer for our portable water tanks, wheel chocks and valve stem extensions for all vehicles. - 3. We are still working with Northern Cochise Community Hospital on the wheel chair van. We hope we continue the great relationship that we have with them.
- 4. Northern Cochise Community Hospital will be here, at the Sunsites-Pearce Fire District station, on October 18th to perform a flu shot clinic. We will post the remaining details as soon as they are available.
- 5. Firefighter Garner will be graduating Paramedic School on October 11, 2014. We are extremely proud of him.
- 6. We did not receive the fuels reduction grant from Arizona State Forestry for the Stronghold community.
