Pursuant to A.R.S. 38-431.02 notice is hereby given to the members of the Sunsites-Pearce Fire District Governing Board and the general public that the Sunsites-Pearce Fire District Board (or in lieu of Board, Administrator) will hold a meeting open to the public on January 13, 2015 at 4:30 p.m. at 105 N. Tracy Road in Pearce, AZ 85625.

The Board may vote to go (or, in lieu of Board, Administrator may go) into executive session on any agenda item pursuant to A.R.S. 38-431.03(A)(3), to discuss or consult with the district's attorney in person or via telephonic conference call. Board Members or other participants may attend the meeting by telephonic conference. The following topics and any variables thereto, will be subject to Board consideration, discussion, approval, or other action. All items are set for possible action.

A copy of the agenda provided to the SPFD Board members or Administrator is available for pickup once it is available at SPFD, 105 N. Tracy Road, Pearce, AZ 85625 between the hours of 8 a.m. and 5 p.m. Monday through Friday. Also at that location, the public may review the agenda or request and pay for a copy once it is available.

1. Call to Order- Chairman Robert Fino

Declaration of Conflict of Interest – If a Board member (or in lieu of Board, Administrator) has a conflict of interest, that person will need to declare that conflict prior to any discussion of the agenda item and be excused from the vote on the issue.

2. The Pledge of Allegiance

3. Call to Public – Consideration and discussion of comments and complaints from the public. Those wishing to address the Sunsites-Pearce Fire District Board (or in lieu of Board, Administrator) need not request permission in advance. The Fire District Board is not permitted to discuss or take action on any item raised in the Call to the Public. (ARS 38-431.01(H)) However, individual Board Members (or in lieu of Board, Administrator) may be permitted to respond to criticism, direct staff to review a matter or ask that the matter be placed on a future agenda. The Fire District Board cannot discuss or take legal action (and in lieu of Board, Administrator may not discuss or take legal action) on any issue raised during the Call to the Public, unless that issue is listed on the agenda and the time of that discussion/action item.

In addition, pursuant to the Bylaws of the Sunsites Pearce Fire District Article III, Section 2, Rule 2, F, Conduct of Meetings regarding the Limitation of Debate, No Member of the Board or public shall be allowed to speak more than once upon any one subject until all Board Members have had an opportunity to speak. No Member of the Board or the public shall be allowed to speak for a period longer than three minutes without the leave of the presiding officer. Citizen groups shall identify themselves and shall be

represented in presentation to the Board by one of the members of the group and cumulative or redundant speeches to the Board on the same issue shall be terminated at the discretion of the presiding officer.

4. **Action Agenda:**

- A. **Discuss, Vote, and possibly take action in the filling of the two vacant Fire District Board seats by Mr. Brian Allen, Mrs. Joanna Baker, or any other member of the public that presents a letter of interest.**
- B. **Advise public of the notification that the Sunsites-Pearce Fire District Board will be attending the annual Arizona Fire Districts Association conference meeting in Laughlin, NV during the week of January 15th-18th 2015 for training. No voting or discussing of official fire district business will be conducted during this time.**

5. **Adjourn**
