Sunsites-Pearce Fire District Regular Meeting October 20, 2015

1. Call to Order

The meeting was called to order at 6:00 p.m. by Chairman Robert Fino.

2. Roll Call

- A. Attendance and Confirmation of Quorum Chairman Robert Fino, Board Member Brian Allen, Board Member Jason Simmons, and Board Member Tom Whiteman were present. Chairman Fino confirmed that all Board Members were present and that a quorum was met.
- B. Board Members Absent No Board Members were absent.
- C. Declarations of Conflicts of Interest No Board Member declared a conflict of interest.
- **3.** The Pledge of Allegiance Fire Chief Josh Steinberg led the attendees in the Pledge of Allegiance.
- **4. Recognition of Guests -** Mr. Eric Soderstrom and Mrs. Jessica Jones were introduced as candidates for the Interim Board Position.

5. Consent Agenda

- A. Approval of Warrant Reports;
- **B.** Approval of Expense Reports Chairman Fino moved to approve the consent agenda which comprises the Warrant Reports and Expense Reports; Board Member Allen seconded the motion. Vote: All in favor, motion carried.

Approval of Minutes of the September 22, 2015 Regular Meeting and October 6, 2015 Special Meeting

Board members reviewed minutes of both meetings. Board Member Whiteman moved to approve the minutes of the September 22, 2015 Regular Meeting and minutes of the October 6, 2015 Special Meeting, both as written; Chairman Fino seconded the motion. Vote: All in favor, motion carried.

7. Call to Public

Mrs. Jessica Jones read ARS 48-805 and 48-262 regarding annexation procedures. Mrs. Louise Lance offered her opinion supporting legal counsel attending all board meetings, and commented on various board procedures.

8. Financial Reports

A. Review, discuss, and possibly approve the financials for September 2015. Chief Steinberg presented the financials for September 2015. (See September 2015 Financial Report attached.) Following discussion, Chairman Fino moved to approve the financial report for September 2015 as presented; Board Member Allen seconded the motion. Vote: All in favor, motion carried.

10. Old Business

A. Interview applicants for Interim Board Member Appointment

Chairman Fino asked both candidates, Mr. Eric Soderstrom and Mrs. Jessica Jones, to offer their opinion of Fire District at this time and what they would envision for the future of the Fire District. Both candidates were given the opportunity to respond.

11. Executive Session. Chairman Fino offered the option of voting to adjourn to Executive Session and further discuss the applicants, or remain in Public Session and vote by ballot. Board Members agreed that there was no need for further discussion in Executive Session.

12. Appointment of Interim Board Member

Chairman Fino instructed that ballots be distributed to Board Members. Ballots were to be filled out, signed by voting member and retained for public record. Following the vote, Chairman Fino welcomed Mrs. Jessica Jones as Interim Board Member, and thanked Mr. Eric Soderstrom for his interest in the position and invited him to continue to be an active part of the public at the meetings.

13. New Business

A. Review, discuss, and possibly approve the Cochise County Public Safety Mutual Aid Agreement

Chief Steinberg reported that Mr. Whittington, the District's legal counsel, stated he wished to confer with the County Attorney and update the Agreement before presenting it to the District Board for consideration and possible approval. Chairman Fino moved to table this matter until such time as we are contacted by Mr. Whittington; Board Member Whiteman seconded the motion. Vote: All in favor, motion carried.

14. Requests from board members for future agenda items. No requests were offered.

15. Adjournment.

Chairman Fino made a motion to adjourn the meeting at 6:44 p.m.; Board Member Whiteman seconded the motion. Vote: All in favor, motion carried.

Wildland:

1. We have had 2 additional Wildland assignments since the last meeting. The Ketchum and Clearview Fires. We currently have billed out to Arizona State Forestry Division \$91,294.33.

Out of District Fires:

1. We currently have \$44,027.78 billed out for 11 fires that occurred outside of the district boundaries. One fire will be billed shortly. There has been one additional out of district assignment, the Cross Creek Fire.

Hazardous Materials:

1. Apache Nitrogen in planning a training drill. Date to be determined

Maintenance:

- **1.** M-302 had two batteries and starter replaced in house. Total cost was approximately \$400.
- **2.** E 301 had a water tank leak which was repaired in house. No additional material costs.

Communication:

- 1. We are currently planning the annual Open House for October 24, 2015, 11 am to 2 pm. Flyers have been distributed. We thank Life Net Arizona and the Air Methods Corporation for sponsoring this event and their continued support.
- 2. We have completed Fire Prevention at the Cochise, Pearce, and Ash Creek schools. We will have one more small school to complete on October 23, 2015.
- 3. We have begun sending our Self Contained Breathing Apparatus tanks to United Fire in Tucson for hydrostatic testing. The cost is approximately \$31 per bottle.
- 4. A windsock has been installed here at the station. We would like to thank Life Net for donating the cage and windsock and Fire Fighter Makarewicz for the great installation.

- 5. We will be completed an Ambulance Standby on October 24, 2015 at the Amerind Foundation.
- 6. We have renewed our Radio Service Authorization License with the Federal Communications Commission.
- 7. Benson Fire Department will be utilizing our Fire Prevention Trailer from October 20, 2015 to October 22, 2015.
- 8. We are in the process of preparing two grants, the Volunteer Fire Assistance (VFA) and the Assistance to Firefighters Grant (AFG).
- 9. This month is Breast Cancer Awareness month. The on duty crews will be wearing their pink lettered shirts this month. These shirts were purchased last year and no additional funds have gone to the purchase of these shirts this year.
- 10. Local Emergency Planning Committee report, The LEPC's last meeting was October 16, 2015. We are in the planning stages for the next site visit. Again the LEPC is seeking Tier II reporting facilities within Cochise County to complete site visits and pre plans. The next is November 20, 2015.
- 11. Cochise County Fire Chief's Association report: The association will be discussing an updated Cochise County Mutual Aid Agreement. The next meeting is October 28, 2015 at Bisbee Fire Department.
