### Wildland:

1. We have had no additional Wildland assignments since the last meeting. We currently have billed out to Arizona State Forestry Division \$92,665.53.

#### **Out of District Fires:**

1. We currently have a balance of \$44,889.03 outstanding for 16 fires that occurred outside of the district boundaries since 2012. Of the 16 fires, seven incidents are in collections, four have been paid in full.

#### Maintenance:

- 1. E-302 had a water tank leak. Tank was welded. No additional cost.
- 2. T-303 was taken to W.W. Williams for the front end repairs that are needed. We will hopefully have this unit back within a week to week and a half.
- 3. M-302 had serpentine belt and 2 idler pulleys replaced for the cost of \$132.32 in parts.
- **4.** E 305 was pump tested, T 304, T 303, E 306, E 307, C 30, E 301 were flow tested, and all ladders were tested by W.W. Williams on December 10, 2015. One ladder had a halyard failure and needs replacement. E 305 needs 3 valves rebuilt but did pass the testing. E 302 will be sent to W.W. Williams for maintenance and pump testing soon.
- 5. All fire extinguishers have had their annual inspection completed by United Fire on November 19, 2015.
- **6.** Richland station underground propane piping was replaced. Cost for supplies was \$232.58.
- 7. The winch cable for T 304 was replaced for a cost of \$162.78.
