EMS training covered spinal motion restriction, standing orders.
2. All Full Time personnel attended the Traffic Incident Management training on June 2, 2016 at the Willcox Fire Department and on June 16, 2016 at the Elfrida Fire District.
3. Captain Garner and I instructed a Rural Emergency Medical Services class for Cochise College Paramedic Program on June 6, 2016. We instructed the class here

Wildland:

1. We have had 3 additional Wildland assignments since the last meeting. The Horse Country, Jordan, and Cibola NM are out of district and billable. We have a total of \$1,738.65 billed to the Arizona State Forestry Division. Command 30 is in New Mexico on assignment. We are planning a controlled burn for Wednesday, weather permitting, on Riggs Ranch on Hwy 181.

Out of District Fires:

1. We currently have a balance of \$44,329.03 outstanding for 16 fires that occurred outside of the district boundaries since 2012. Of the 16 fires, eight incidents, with a total of \$ 21,453.13 are in collections, four have been paid in full.

Emergency Medical Services:

June 4 total billings to date are \$ 23,520.54.

Hazardous Materials:

1. Cochise County Haz Mat team planning meeting on July 7, 2016 at the Sierra Vista Fire and Medical Services station 363.
2. Next quarterly training will be August 16, 2016 at the Fry Fire District and covering incident command.

Maintenance:

1. Engine 306 air conditioning not working. We will have this issue assessed and mitigated as soon as possible.

Communication:

1. The Wildland Fire Hazardous Fuels grant project continues and should be finished by June. We have met the existing objectives for the grant. The final
