- 3. Firefighters Austin, Escojido, and Hughes have completed the Officer I, II, and Incident Safety Officer course in Sierra Vista. They are awaiting their test results.
- 4. We will have 4 personnel attending a confined space class in Nogales. The dates are November 12<sup>th</sup>-16<sup>th</sup>. The class is free.
- 5. We participated in a full-scale exercise in Sierra Vista on October 11, 2018.
- 6. Doug Bays from Lee Bays company will be here on November 1, 2018 to give an in service on our new air quality monitors.

#### Wildland:

1. We have had no additional Wildland assignments since the last meeting. We have a total of \$104,638.05 billed to the Arizona Department of Forestry and Fire Management. We have resumed availability for out of state assignments.

#### **Out of District Fires:**

1. We currently have a balance of \$61,941.44 outstanding for 24 fires that occurred outside of the district boundaries since 2012. Of the out of district fires, nine incidents, with a total of \$ 29,210.37 are in collections. Total unpaid balance that is not in collections is \$ 32,731.07

## Hazardous Materials:

- 1. The Cochise County HazMat team quarterly training will be held on November 9, 2018 in Benson.
- 2. We did respond to one call for carbon monoxide and one call for power lines down

## Maintenance:

- 1. We have worked with Lone Mountain Communications to identify and repair an intermittent radio issue with our channel 1. The issue appears to be resolved but we will continue to pay close attention to this channel.
- 2. E 306 needed front U-Joints replaced. U-Joints replaced by in house mechanic for a total parts cost of \$91.62
- 3. Our new Patrol 30 received lettering for \$562 and the radio installed.
- 4. T 304 has rear preconnect leaking. Valve was found to be failing. Valve replaced in house for parts cost of \$65.00
- 5. Roof of Sunsites station leaking. Found gap at air conditioning inlet to station. Sealed the gap with sealant in house.

## **Communication:**

- 1. On site fuel tanks: We have received the information needed through SOCO. We are now looking for a less expensive base options for the tanks. The electrical quote is \$720.
- 2. Richland Station vandalism update: I am still seeking a contractor to repair the doors.
- 3. The fire hydrant committee: Nothing new to report.
- 4. We are participating in Trunk or Treat at the VFW Post 9977 on October 31, 2018.
- 5. We have had Spillman installed on our mobile data centers (vehicle mounted computers) and our station computers. This is a version of computer aided dispatching which will allow us to see the same map that our dispatch sees and is more up to date. This will improve our response to calls for service and allow us to work more closely with other responding agencies. We thank the Willcox Department of Public Safety and Cochise County Sheriff's Office.
- 6. We have completed fire prevention at Pearce, Ash Creek, and Cochise Elementary schools. We will be assisting Willcox Fire with fire prevention on November 1, 2018.
- 7. We conducted an ambulance standby at the Amerind Foundation on October 27, 2018.
