- 4. Monthly company training: CPR refresher and Swiftwater awareness.
- 5. Patrol-30 with Captains Hershey and Tingle participated in a wildland fire preparedness drill with the US Forest Service on May 30, 2019.
- 6. We participated in Cochise County Regional Technical Rescue Team tabletop exercise at Freeport McMoran Mine in Bisbee on June 6, 2019.
- 7. I will be attending the Southwest Trauma Conference on June 27<sup>th</sup> and 28<sup>th</sup>.

### Wildland:

1. We have had 4 additional Wildland assignments since the last meeting. The I-10 MP 327, Half Moon, and Woodbury were out of District, the Havasu was in District. We have a total of \$ 0 billed to the Arizona Department of Forestry and Fire Management. All recent invoices have been paid. The Woodbury bill is completed.

### **Out of District Fires:**

1. We currently have a balance of \$64,972.91 for the outstanding fires that occurred outside of the district boundaries since 2012. Of the out of district fires, nine incidents, with a total of \$29,210.37 are in collections. Total unpaid balance that is not in collections is \$35,762.54.

### **Emergency Medical Services:**

- 1. All vehicles are receiving their annual DOT inspections.

#### **Communication:**

- 1. On site fuel tanks: We have received the information needed through SOCO. We are now looking for a less expensive base options for the tanks. The electrical quote is \$720. I have completed the drawing and will send it to the State Fire Marshalls office for approval.
- 2. The fire hydrant committee: New storage tank is in. Awaiting word of it being operational.

- 3. Cochise County Health Department: We are still hoping to still conduct a clinic in our area. The Health Department has declared a Hepatitis A outbreak in Cochise County. We have been assisting them with vaccination clinics and overhead support.
- 4. We did host a Hepatitis A vaccination clinic on June 21, 2019.
- 5. We have hired 4 new part time employees. They are all on orientation status and learning our District quickly.
- 6. We have release Amanda Ratcliff and Sileigh Levine due to inactivity.
- 7. Windsong dump site: We have burned the site but have found that citizens are still dumping at that location. We will work with other local organizations to try to stop the illegal dumping.
- 8. Healthy Communities: No new report.
- 9. One of our training vehicles had its rear tires stolen at the Richland Station. I have made a report to the Cochise County Sheriff's Office.
- 10. The new engine is nearly complete. It is being lettered now. We should have this vehicle fully in service within the next two weeks.
